

SCHOLARSHIP COMMITTEE GUIDELINES

First United Methodist Church--Fort Smith, Arkansas

1. The FUMC Scholarship Committee makes awards utilizing funds contributed to the *Memorial Scholarship Fund*.
2. *Memorial and In-Honor of gifts* received are over and above the established church Budget and are not to be considered a part of or used for any portion of the budget prepared by the Finance Committee and adopted by the Administrative Board.
3. Gifts of a substantial amount (\$100 or more) memorializing an individual are subject to the recommendations of the bereaved family.
4. Restricted contributions (specifying the recipient) can be accepted from organizations but not from individuals.
5. The scholarship fund is available for deserving students who are active members of FUMC continuing education above the high school level.
6. While scholastic record and other factors will be considered, financial need is of particular concern to the Committee.
7. Awards are made on a semester basis. Assuming recipients are making satisfactory academic progress, they may apply for a continuation of scholarship assistance.
8. Initial application for a scholarship should be made on a form provided by the Scholarship Committee. Any information which the applicant believes may be helpful to the Committee should be included.
9. A minimum of one letter of recommendation must accompany their application.
10. Applications for 2010-2011 school year should be received no later than **June 1st**.
Previous scholarship recipients who would like to be considered for additional scholarship funding, are asked to also submit a letter of intent and a copy of their school/college transcript.
11. The amounts of scholarships awarded will vary depending upon the applicants' circumstance and on the availability of funds. For the same reason, awards to a recipient receiving continuing funding may vary from semester to semester.
12. Applicants should not expect FUMC to fund all college expenses. Before applying to FUMC, applicants should have sought financial aid through Pell Grants, guaranteed student loans, the State Scholarship Program, and from other common sources of student financial assistance.
13. If for any reason a recipient drops out of college before completing a semester for which FUMC scholarship funds have been awarded, that semester's award shall be refunded to FUMC unless an exception is specifically approved by the Scholarship Committee. Recipients are to forward an (official) transcript copy to the Scholarship Committee at the conclusion of their academic year. Failure to do so will disqualify future scholarship consideration.
14. Applicants understand that the names of scholarship recipients may be publicized in church publications including newsletter, bulletin, other. Recipients are encouraged to be present during the designated "College Recognition Sunday".
